We are pleased to invite you and your team to enter the 2012 Pomeroy Inn & Suites Prairie Showdown. The event will take place at the Grande Prairie Curling Club in Grande Prairie, AB, from Thursday March 8 to Sunday March 11, 2012.

This new event is expected to fill a void in the curling schedule as teams prepare for the Player's Championship and prepare for next season.

Because we missed the deadline for registration of October 17, 2011, no WCT or CTRS points will be awarded this year. The intent is to continue the event next year and those deadlines will be met.

The format of the event will be triple knock-out with six qualifiers. Sixteen men's and sixteen women's teams will compete for a \$100,000 purse (\$50,000 each)

The prize purse of **\$50,000** for this year's event will be distributed as follows.

Games will be 8 ends with a full extra end to break a tie. A draw to the button will determine hammer. The first draw will be at 5:00 pm Thursday and the final is set for 3:30 pm Sunday.

The entry fee is \$1000 payable to GP Cash Spiel. The cheque may be post-dated to February 15, 2012 and must accompany your entry form. The deadline for entries will be February 1, 2012. No refunds will be issued after the February 17, 2012 unless your spot can be filled.

If at any point there is a change to team personnel as it was submitted, we must be notified immediately.
